New Tower – The Perfect Patient Experience

UF Health Shands Hospital continues to expand as the much-anticipated Cardiovascular and Neuromedicine (CVNM) Hospital is set to open on December 10, 2017. This new 8-story tower will be comprised of 216 beds while featuring two links to connect to the UF Health Shands Cancer Hospital via a bridge and ground to floor access. The CVNM Hospital will service high acuity patients and provide care via operating and procedural rooms, intensive care units as well as step-down units.

Medication needs of the CVNM Hospital will be serviced by three inpatient pharmacy areas: the main pharmacy, the 2nd floor OR pharmacy, and a 7th floor satellite pharmacy. The main pharmacy,

New Practitioner Welcome

This year we welcome two new preceptors to our department, Chris Campbell and Kelly Maguigan. Chris, our current Pediatric Intensive Care Unit preceptor, completed his PGY1 and PGY2 in Pediatrics at Augusta University Medical Center and the University of Georgia College of Pharmacy. Next year, he will be serving as Co-Coordinator for grand rounds, and hopes that within this position, he may learn more about residency training at UF Health Shands and how to get more involved in resident research and mentorship. What most excited him about coming to Shands was the diversity of the patient population as well as all of the individuals he interviewed with and would be able to work with. Within his role as shared faculty, he will be able to participate in multidisciplinary rounds and precept students and residents while teaching and mentoring students throughout the pharmacy curriculum. Within his rotation, he would like to continue to increase the services that we as pharmacists can provide for pediatric ICU patients. He believes that not only does the PICU host a unique patient population but it also offers a rich learning environment with a layered learning model.

located on the ground floor, will remain open 24/7. It features a state of the art clean room with two separate preparation rooms, one for sterile hazardous medications and the other for sterile nonhazardous medications. The main pharmacy will also be utilizing Controlled Substance Manager for managing narcotics. The 2nd floor OR satellite will service the OR, procedural areas, the PACU, as well as the pre-op areas, and the 7th floor satellite will service all of the ICUs and step-down units.

Several pilots are planned to evaluate operational efficiency through use of technology. One major change would be employing first dose dispensing through the carousels. Satellite Pharmacy Manager is preparing to go live in the North tower with the hopes of transitioning all of the satellites to this technology and having it ready for when the new hospital opens.

With the upcoming opening of the CVNM Hospital, plans have already been established for transferring patients. Units that will be moving to the new hospital from the North tower include units 24 (TCV patients), 25, 54 cardiology, 10-5, 11-5, 82, and 4 west vascular. Currently there are no finalized plans for utilizing the empty patient rooms that patients will be transferred from. In an effort to make this transition and opening a success, surveys are going to be conducted to gain feedback about the transition. Nurses will be the first group to be surveyed, conducting a survey even before the new hospital opens, and then again after the opening. These surveys will assess turnaround-time, phone and in-basket requests, as well as Omnicell and drug information questions.

From piloting new operational efficiency technology to ensuring our pharmacies and units are state of the art, the hope is to give patients the perfect patient experience when visiting the CVNM Hospital.

Making A Difference in Infectious Disease (MAD-ID) 20th Annual Meeting *May 2017 in Orlando, FL*

Jarred Bowden, Sasha Premraj, and Kayihura Manigaba attended the MAD-ID conference along with RPD Ken Klinker. Jarred presented his research titled “Implementation of a Beta-Lactam Therapeutic Monitoring Program,” Sasha presented her project titled “Retrospective Evaluation of Penicillin Allergy Skin Testing at a Large Academic Medical Center,” and Kayihura presented “MSSA Endocarditis: A Single-Center Review of Oxacillin Dosing Strategies.” Ken Klinker also presented “Impact of an Extended Infusion Beta-lactam Strategy on Outcomes in Critically Ill Patients with Pseudomonas Infections.” The conference was focused on antimicrobial stewardship, with many interesting topics including updates to vancomycin monitoring recommendations, antibiotic dosing in special populations, antimicrobial stewardship in geriatric populations, and current challenges related to susceptibility testing and antimicrobial breakpoints.


